Montreign Casino Resort in Sullivan County Means Business

Preliminary work has begun on one of the three new casinos that will be built in upstate New York. Property is being cleared at the future site of the \$1.1 billion Montreign Resort Casino in the Sullivan County town of Thompson, in the Catskills 75 miles northwest of New York City.

Montreign, a division of Empire Resorts, will be built on the site of the former Concord Resort Hotel in Monticello. The casino will be part of a larger destination resort call the Adelaar. More than just a casino, Adelaar is poised to become the most comprehensive destination gaming resort in the northeastern United States. The gaming facility at Adelaar will include:

- **Montreign Resort Casino:** An 18-story casino, hotel and entertainment complex featuring an 80,000 sq. ft. casino, 391 luxury rooms, multiple dining and entertainment options, and meeting and conference space.
- **Indoor Waterpark Lodge:** A 350 room, family-style, non-gaming resort featuring a wide range of amenities including an 80,000 sq. ft. indoor water park, dining facilities and other recreational opportunities.

- **Entertainment Village:** A pedestrian-friendly, 200,000 sq.ft. entertainment village featuring multiple dining opportunities and specialty retail shops.
- **Monster Golf Course:** This famous course will be redesigned and improved by Rees Jones, "The Open Doctor". It will be playable by golfers of every skill level and yet exciting enough to the experienced golfer.

After decades of waiting, Sullivan County stands on the threshold of its most significant economic development - Adelaar and Montreign Resort Casino. This project is the economic catalyst for the rebirth of tourism and hospitality in the Catskills. Upon opening, it creates over 2,400 new jobs with \$73 million in new wages and benefits pumped into a long-struggling and decaying Sullivan County economy.
