Minutes:

Mr. Richter made a motion, seconded by Mr. Gerlach to approve the minutes of the February 7, 2017 meeting. Carried.

Treasurer's Report:

Mr. Mackerer reviewed the Treasurer's Report with the Board, noting that equity totaled \$140,000 and liabilities and equities totaled \$238,000. Mr. Keeler made a motion, seconded by Mr. Richter to recommend approval of the treasurer's report to the full board. Carried.

Mr. Tucker asked the Board to consider expending \$5,000 toward the City of Hudson's DRI application. He noted CEDC had contributed \$10,000 and had asked the IDA to contribute \$5,000. This contribution would match the City of Hudson's contribution. Mr. Tucker noted that the ABO had issued an opinion last year allowing such payments. Mr. Gerlach made a motion, seconded by Ms. Sterling to approve a payment of \$5,000 to be applied to the DRI application cost. Carried.



Financial Committee Confidential Evaluation Summary:

The Board reviewed and approved the committee evaluation summary for 2016. Ms. Sterling made a motion, seconded by Mr. Pierro to approved the summary as submitted. Carried.

With no further business to discuss or public comment, a motion was made by Ms. Sterling and seconded by Mr. Pierro. Carried. The meeting adjourned at 8:47am
